## EXCEPTIONAL CHILDREN SERVICES

### Evidenced Based Practices for Students with Autism

Autism spectrum disorder (ASD) is a development disability that can cause significant social, communication and behavioral challenges. People with ASD may communicate, interact, behave, and learn in ways that are different from most other people. The learning, thinking, and problem-solving abilities of people with ASD can range from gifted to severely challenged. Some people with ASD need a lot of help in their daily lives; others need less.

A diagnosis of ASD now includes several conditions that used to be diagnosed separately: autistic disorder, pervasive developmental disorder not otherwise specified (PDD-NOS), and Asperger syndrome. These conditions are now all called Autism Spectrum Disorder. As more and more students are diagnosed with Autism Spectrum Disorder, more demand for teachers who are trained to work with this special population of students is imperative.

The Professional Development Center on Autism Spectrum Disorders has identified 27 Evidenced Based Practices that are proven effecting in working with students on the spectrum. Online modules for 24 of the 27 EBPs are now available with no costs to participants. These can be found at [www.autisminternetmodules.org](http://www.autisminternetmodules.org)

and provide resources, videos and materials to assist teachers in implementing these Evidenced Based Practices.

The Kentucky Autism Training Center (KATC) and OVEC now partner to provide training and support to teachers of students on the spectrum. There are currently six ASD training sites at schools in the OVEC region. A training site receives monthly classroom visits, training, coaching and support to assist teachers in implementing the Evidenced Based Practices identified successful for students on the autism spectrum. Great success is evident in many of the classrooms included in this initiative as evidenced by decreases in inappropriate student behavior and an increase in on-task student behaviors which equates to higher levels of learning for all students. Exceptional Children Services is excited to provide this service to the OVEC region and is looking forward to supporting additional classrooms in the future.

## KID- FRIENDLY PROJECT (RTTD PROJECT DISTRICTS)

### College and Career Readiness Counselors



CCRCs met as a large group for a Professional Learning session on November 10 in Elizabethtown. Topics and activities for the day included “telling our story” and hearing from Superintendent Michael Ford (Russell County) about the value he places on the CCRC role in his district, and the importance of expanding this position to other districts throughout the commonwealth.

In his comments to the group, Mr. Ford talked at length about the need he sees for the CCRC function in districts. He said “One of the ways to appreciate someone is to imagine your life without them.”

He mentioned that, other than coaches, he has received more positive notes from parents about the CCRC than for any other single position in the district. He also talked about the CCRCs role in bringing others together around a “life-ready” approach to student success. He discussed the need for CCRCs to “get the word out” in front of school boards and others so that this role can grow and develop.

### Change to the Communities of Practice Learning Forum VIII

There is a change in the grade-level focus for each 2017 Community of Practice forum. The Forum on February 28 is now for elementary grades; the March 2 Forum is for secondary. Both are still planned for Bowling Green. Schools may use CoP or kF PD funds for this event. Registration information will be forthcoming. ### Working with FranklinCovey After the Grant

Grant leadership has been working with FranklinCovey to propose a reasonable plan for sustaining the LIM work that has occurred in our districts. You have seen updates about this in past DSRs, but the following are the most current three options.

- **Option 1:** Kid-FRIENDLY Schools may be considered a 7 Habits School FREE of charge (you would not be considered a Leader in Me school). There will be NO intellectual property licensing fee, and you will NOT need to remove or paint over any language or murals representing the LIM work.
- **Option 2:** If you select to be a LIM school, you have the following choices:
  - a. Membership-\$7,500 (If interested, please let Donna Link know, and she'll have Nolan Marx send a breakdown of what this fee covers.)
  - b. IP/Website Access-\$1,250 per school per year
- **Option 3:** You may choose to discontinue.


## Win Learning After the Grant

## PROFESSIONAL LEARNING FOR PRINCIPALS – DR. MICHAEL CHIRICHELLO

Dr. Michael Chirichello provided a professional learning for two days with 22 OVEC administrators, primarily principals. One of the principals attending is Andrew Terry, Principal of Anchorage Schools. Andrew shared his thoughts about this training. “The leadership training provided by Dr. Chirichello at the end of October sponsored by the OVEC group was one of the most powerful and reflective professional developments I have had the privilege to attend. Dr. Chirichello challenged me to not just think of leadership as a whole but also to look at myself and really be thoughtful about what kind of leader I want to be. Through group conversations and engaging activities we were able to process together, things like ‘What is leadership? What is the principal’s role? and How do we transition from groups to teams?’ All of these topics and much more pushed me to really be thoughtful about who I want to be as a leader in our school. I am excited to continue this journey with my peers in leadership as well as learn alongside Dr. Chirichello.”

On December 5<sup>th</sup> Dr. Chirichello will hold a Skype session with the participants. He has asked communicated with them in email the following for consideration prior to the session:

*“The purpose of the online sessions is to share the applications and practices you have taken back to your school (and/or district) from our sessions. Our conversations will focus on the following two outcomes from our sessions:*

### **OVEC/PEBC/SHELBY COUNTY THINKING STRATEGIES INSTITUTE**

The Thinking Strategies Institute (TSI) was held November 15-18 at the Blair Center, Shelby County Schools. We had the opportunity to learn from the PEBC Consultants Mrs. Michelle Morris-Jones and Dr. Stevi Quate. Days 2 and 3 of the Institute provided the 73 participants the opportunity to visit in the lab classrooms in Shelby County Schools and to meet the coaches too. Working with Tracey Harris and Tina Tipton at OVEC to make this learning be so successful is Lora Shields, Staff Developer for Shelby County Schools! A BIG thanks for Dr. James Neihof, Superintendent, and staff for partnering with OVEC on this Institute and allowing all of us to learn from the staff in Shelby County.

The next TSI will be March 14-17 in Shelby and Franklin County districts. There are 107 registered for this Institute. Included in the registrations are the OVEC districts and Campbell County and two schools from Jefferson County, Moore High School and Frost Middle School.

### **PEBC - ADMINISTRATOR SUPPORT FOR IMPLEMENTATION OF THINKING STRATEGIES**

Scott Murphy, Education Director from PEBC, will work with administrators for a day of professional learning on February 21, 2017. Scott Murphy will blend content with modeling practices that administrators could incorporate into their own leadership and language.

- Creating cultures of thinking, learning, and literacy
- Examine resources and ways to build capacity as a network of support for growing instruction
- Model the kind of coaching questions, feedback and relationships that grow teachers' practices and reflection

### **HI-Q2 MATH PROJECT (MATH/SCIENCE PARTNERSHIP GRANT)**

The Hi-Q2 Math Project will host the first professional learning for participating districts on December 8<sup>th</sup>, with Dr. Debbie Thompson. The first training is "Principals to Action." This project is about how to support and build a coaching cadre in our region. There are a total of 21 participants in the project, including administrators and coaches, from the following school districts: Bullitt, Eminence, Henry, Owen, Grant and

Shelby. The focus is on how to support teachers, through the instructional coaches, and then as administrators how learning more about how to support the coaches. Administrators have committed to 33 hours of professional learning for this year and the coaches to 65 hours for the year.

The next event is January 9,10,11 with the Magnify Learning Indiana team on PBL! Many of our participants have had PBL professional learning, but this one is different in that it is developed for coaches and how you coach teachers using PBL.

The Hi-Q2 Math Coach Facilitator began on December 5<sup>th</sup>. Cricket McClure will serve in this role on a part-time basis and will spend time in the districts supporting the coaches. The Project Director is Tina Tipton.

## ***Guided Reading 101***

Guided Reading is small group instruction that provides differentiated teaching of reading strategies. This small group instruction helps students develop good reading habits, problem solving skills, and strategies to use when reading independently. The one-day professional learning concentrates on three aspects:

- Organization and management (schedule, literacy stations, etc.)
- Assessments and data driven decision making
- Strategic teaching in small groups

**What is Progress Monitoring???**

Progress monitoring has been defined as the tools and methods used to collect, graph, and *analyze* data ultimately measuring progress in order to provide evidence of student performance specific to IEP annual goals. Progress monitoring is SO important because it:

- Measures progress a student is making toward an annual goal
- Determines effectiveness of specially designed instruction
- Guides instructional decisions and in making adjustments to instruction
- Determines current level of learning/behavioral performance
- Provides data for the reevaluation process
- Determines if the student continues to meet eligibility for specially designed instruction

**Learning Targets:**

- Define & Identify methods of measurement
- Collect, Graph, Analyze, Interpret & Communicate progress monitoring data
- Make instructional decisions about a student's progress toward annual goals
- Demonstrate the linkage between progress monitoring & writing present levels of performance for annual goal development
